## **Clarification of definitions**

### **Special rate or charge member means:**

- (a) a member who owns property subject to the special rate or charge;
- (b) a member who occupies property subject to the special rate or charge; or
- (c) a member nominated by the owner or occupier of property subject to the special rate or charge to serve as their representative for so long as that nomination continues and is not withdrawn.

### **The special rate or charge:**

Means a special rate or charge declared by the Council pursuant to section 163 of the Local Government Act 1989 for the benefit of the Diamond Creek

### **Who is eligible to be a member?**

- (1) A person who owns property subject to the special rate or charge is eligible for membership.
- (2) A person who occupies property subject to the special rate or charge is eligible for membership.
- (3) A person representing a corporation which owns or occupies property subject to the special rate or charge is eligible for membership.
- (4) Any other person that supports the purposes and intent of the Association .

### **Annual subscription and fee on joining**

- (1) There shall be no annual subscription or joining fee for persons eligible for a special rate or charge membership.
- (2) For any other membership please refer to the separate Application for Membership – Non Special Rate Member for which an annual fee applies
