

Welcome to Diamond Creek and welcome to the growing and supportive community of businesses that choose to set up their business in Diamond Creek.



Let's start with the value of Main Street Precincts and why Diamond Creek businesses are an important part of the community.

Main Street Precincts are the central hub of a town. They bring people together to work, shop and socialise. Main Streets act as a meeting place for locals and visitors. They provide space where many social interactions take place, not just shopping.

Main Street businesses are at the heart of these communities and their success is key to a healthy and vibrant main street and local economy. Much of our marketing and promotoins are based on this philosophy and we encourage you to get involved.

Diamond Creek is a Main Street community stretching from the top of the hill in Chute Street through to and along Main Hurstbridge Road towards Hurstbridge. Below is a map of Diamond Creek, highlighting the business precincts.

KERBSIDE TRADING

The Diamond Creek Shopping Precinct is made up of public and private land. Rules regarding kerbside trading vary depending on where within Diamond Creek you operate your business.

Nillumbik Shire Council issued permits are required by traders who wish to:

- display goods on the pavement adjoining their property and/or
- provide outdoor eating for their customers

Nillumbik Shire Council issue these permits to ensure public access and safety.

Some sections of Diamond Creek are privately owned and a permit is not required. The Diamond Creek Plaza and Diamond Creek Shopping Station areas are managed by private property owners or owners corporations.

If you are unsure if a permit required, please speak to your landlord, owners corporation or a Nillumbik Shire Council representative.

PARKING



We all know that customer parking is critical to business survival. Please do your bit and do not park for extended periods at the front of your shop and take a car park from your or your fellow trades' customers.

Nillumbik Shire Council is no different to any other council and will fine people who exceed parking time restrictions. There are sensor cameras in Chute Street, Inglis Street and some parking bays along Main Hurstbridge Road. When a vehicle exceeds the signed time limit a Nillumbik Council Officer is alerted and a fine issued. The Diamond Creek Shopping Station and Diamond Creek Plaza car parks are patrolled by Council Officers.

At certain times of the day, street parking in Diamond Creek is at a premium. Please encourage your staff to park in the free, designated, all day areas in Waigo Way and the carpark in Diamond Street, behind the Shell Service Station. Doing this means they won't be fined and frees up parking for shoppers to the area, who are critical for your business to thrive.

Limited Trader Permit Parking is also available in Wensley Street and at the rear end of Coles which is managed by Nillumbik Shire Council. CRIME PREVENTION

How to protect your business

Businesses need to be extra vigilant with their overnight security. Offenders tend to look for cash and force front windows with jemmy bars or kick in windows to break doorframes. They will most likely target a business that is not alarmed. However there have been cases of alarm systems being tampered with, rendering them inoperable. Generally there is little evidence left at the scene and in the majority of cases, no CCTV camera footage is available.

Police urge businesses to consider the installation of CCTV attached to a monitored alarm system. Monitored alarms can detect if a system has been tampered with. Alarm systems can be purchased from retail stores, online or a professional security company can install. They are well worth the investment and your insurance premiums may also be reduced.

POLICE TIPS

- If you have a CCTV system or alarm, ensure that it is in good working order and that the sensors cover the front door or window. Sensors must be regularly cleaned to remove dust
- Do not leave large amounts of cash on your premises overnight
- Leave an empty cash tray visible and display signage in the window advertising that you don't keep cash on the premises overnight
- Glass windows and doors can be covered with a security film that holds the glass in place if smashed. Police also suggested that a shatter detector is attached to the glass so an alarm is activated once pressure is applied on the glass.

Solving commercial burglaries is a priority for police however we all have a role in preventing burglaries from occurring in the first place. GRAFFITI REMOVAL

Graffiti is ugly, creates a bad impression and needs to be removed as soon as possible.

We want to keep Diamond Creek clean. Graffiti can be removed in two ways:

- using a graffiti removal kit
- by a contractor

Nillumbik Shire Council have Graffiti Removal Kits available for free. These kits are available for businesses to use to remove graffiti immediately - if they are prepared to remove it themselves. Kits are located at Bendigo Bank, Darebin Travel and Wendy's Music School. These kits can be borrowed at any time or businesses can be supplied with their own kit free of charge by contacting Nillumbik Shire Council on T: 9433 3111 or your Marketing Developmetn Manager.

Nillumbik Shire Council employs a contractor to remove graffiti from Council owned assets. In some instances, the contractor may be able to remove graffiti from businesses. If you would like to use this option, graffiti must be reported to the Marketing Development Manager via email, including location details, a brief description and a photograph.

If the graffiti is offensive, please report it to Diamond Creek Police immediately.



TIDY TOWN

Consumer Affairs Victoria has set up a Small Business Self Assessment checklist, designed to help businesses understand which Australian Consumer Law regulations apply to their business activities, and to better understand their obligations when dealing with consumers.
