3. Diamond Creek Marketing and Promotion Renewal Update

4. Council Officers Report

5. Marketing Report

Marketing Plan – H Crundwell to prepare a Marketing Plan prior to the next meeting. This will then be distributed to the members. This was on hold due to the delay in the Special Rate Renewal.

Directory – H Crundwell advised that this is at the design phase and will be printed and distributed prior to the next meeting. Approximately six businesses took up the offer of publishing their logo on the front cover.
